Dear visitors,

Thank you for visiting our website.

Your access to our website is subject to the terms of website use and the privacy policy, as well as the applicable regulations of the Republic of Serbia regulating this field.

By accessing and using our website you commit to unlimited acceptance of these terms of use.

Milanović Water Treatment keeps the privacy of all visitors to this website and protects personal information of the visitors (hereinafter: visitor and/or website user).

Use of information

All Internet users may visit the Company's web site without disclosing any personal information about themselves. We use all the information we collect to facilitate the use of our web site, as well as to prevent misuse and illegal internet activities.

We would like to emphasize that Milanović Water Treatment can collect personal information from website users solely in line with the provisions of the Law on Personal Data Protection ("Official Gazette of the Republic of Serbia", No. 87/2018), (hereinafter: the Law).

Access to information

All information you provide will be stored on our server and can be accessed solely by the persons authorized for data processing for the purposes listed in this policy or any other purposes you have approved of as website users.

Your data will be processed and stored as long as you give us your consent for it.

Use of cookies

Milanović Water Treatment website uses cookies when collecting data.

A cookie is a small textual piece of data sent to your computer when you visit a website.
